TILL CAPITAL ANNOUNCES AMENDMENTS OF PROMISSORY NOTES

Hamilton, Bermuda, April 28th, 2016: Till Capital Ltd. (NASDAQ:TIL TSX.V: TIL) (the “**Company**” or “**Till**”), a Bermuda domiciled company and the majority shareholder of Silver Predator Corp. (TSX.V: SPD) (“**Silver Predator**”), announces that Resource Re Ltd., a wholly owned subsidiary of Till Capital Ltd. has amended the terms of two Promissory Notes (the “**Notes**”) issued by Silver Predator to Resource Re Ltd. to provide short extensions of payments due.

Subject to TSX.V approval, the amended terms for the August 27, 2015 Note are an extension of the due date from April 30, 2016 to June 15, 2016. All other terms of the Note remain unchanged.

Also subject to TSX.V approval, the amended terms for the April 2014 Note include an extension of the second-installment payment date from April 16, 2016 to July 18, 2016, an increase of the annual interest rate on the balance due from 4% to 10% after April 16, 2016 and a provision for certain additional security.
